INFORMATION SOKAOGON FINANCE INC. COLLECTS

Sokaogon Finance Inc. may collect information about you when you browse our website, use our online services, or when entering data into an application for new products or services. We may collect the following categories of information about you: your name, address, email addresses, phone numbers, your date of birth, your Social Security number, and any other information you may provide on applications or other forms made available on our website or online service. We may also collect information about you from third party sources, which we may combine with information that you

provided to us or we previously collected. Sokaogon Finance Inc. may also collect information about your computer or device, Internet browser, pages you visited and information you provide voluntarily, such as your zip code.

BROWSING SOKAOGON FINANCE INC.'S WEBSITE

You can browse anonymously on www.sokaogonfinanceinc.com and other Sokaogon Finance Inc. websites. Once you sign in or begin completing an application, you are no longer anonymous because we need to identify you to provide those services. You can manually delete cookies after each session or set your browser to regularly delete cookies.

SAFEGUARDING INFORMATION

At Sokaogon Finance Inc., we are committed to safeguarding private personal information. We use physical, electronic, and procedural security measures that comply with government standards and guidelines to safeguard information. We have policies and procedures that restrict our employees', agents', and contractors' access to information about you. They have access to your information only on a business need-to-know basis.

COOKIES AND SIMILAR TECHNOLOGIES

A cookie provides us information such as the time of your last site visit and the pages you viewed. Cookies also help us protect you when you conduct business online. They are common on websites and do not harm your computer. Sokaogon Finance Inc.'s cookies do NOT transmit any personal information about you.

Sokaogon Finance Inc. and its third-party partners may use similar technologies (e.g., Web beacons, pixels) to track visitors' activities. This allows us to verify your identity and honor your personal settings (e.g., font size, location), to enhance your online experience and help us improve our services. We may use them to track your online application or the effectiveness of advertisements. Cookies used for tracking advertising do not collect personally identifiable information.

INFORMATION ABOUT ONLINE TRACKING
